

Formal ARC Complaint for Investigation

Donald Emmi - for lying in a sworn statement given 1/14/2020 about Jennifer Emmi his wife. He lied that he and his wife were separated since September 2019. They were never separated. He lied that his wife had an affair with a Prince. No such affair ever occurred. Donald Emmi lied that he sought a divorce after the fake affair. No such thing ever happened. Donald Emmi lied that he owned the ranch property and he did not. He trespassed and did property damage when he broke through the gate and broke the house door to gain illegal access to Jennifer Emmi who fled there with the couple's three children after Donald Emmi hit Jennifer Emmi, bruising her face severely on the evening of January 8th, 2020 when he came home roughly 9:45 pm high on cocaine and woke the children. Donald Emmi lied that he went to the ranch on 1/14/2020 for a birthday celebration. No such celebration was planned. Donald Emmi lied that his wife

Jennifer Emmi tried to kill him. No such thing ever happened. Why would he break down a door and gate and would Jennifer lock a door and gate if she wanted to kill him or invited him to a party? The only person who ever had any injuries was Jennifer Emmi who when arrested due to the false claims made by Donald Emmi was taken to Castle Rock Adventist Hospital and given a CT Scan due to severe facial bruising caused by Donald Emmi 8 days prior that was still concerning enough the doctor ordered a scan before Jennifer was taken into custody. Deputies in Douglas County rushed Jennifer Emmi to Jefferson County on January 16th/17th, 2020 to see the judge so that the proper person (Donald) could be put in jail once the facts were revealed and corrected. Unfortunately, Donald Emmi was able to continue his manipulation and lies and weaponized the criminal justice system against Jennifer Emmi and even her mother when she tried to gain Grandparent's Rights for the three minor children, the true victims in this.

The lies and false statements under oath and to public officials, judges, police, politicians, the media, and to the public has absolutely and wrongfully destroyed the life of Donald Emmi's wife and mother of his children, Jennifer Emmi. Jennifer Emmi is also now falsely imprisoned at Denver Women's Correctional Facility for wrongful convictions and a 10-year prison sentence and is extremely ill, has suffered partial blindness, multiple blood clots making her dependent on a wheelchair, she has difficulty breathing, and risks dying without even knowing what her children currently look like because Donald Emmi is so cruel he denies Jennifer Emmi despite court orders ^{currents} pictures of her children. She has had no contact with her children since January 14th, 2020, nearly three years and was a very devoted, hands-on mother, even by Donald Emmi's own testimony that "she was and always has been an excellent mother," yet he has stripped her completely of motherhood. The truth must be revealed.

Samual Stoorman - Donald Emmi's legal counsel and co-conspirator that manipulated and perpetrated the lies about Jennifer Emmi and her false criminal acts to the courts. Samual Stoorman misrepresented many false claims to the courts and to judges and his legal ethics are very much in question. He helped to abuse the three minor children and alienate them from their mother Jennifer Emmi and their grandmother, Barbara Crist. Samual Stoorman received sealed criminal affidavits not even available to Ms. Emmi's own counsels, and corresponded with Noelle Kerridge and members of the Jefferson County District Attorneys office to wrongfully prosecute Jennifer Emmi. Samual Stoorman was aware of the conflicts of interests. He posed the offer on January 20th, 2021 to Ms. Emmi's counsel that if Ms. Emmi gave up all the marital assets, the criminal cases could go away and a path could be created to the children. He is a liar and very unethical and his license to practice law should be investigated.

All licensed attorney in Colorado worked with Samual Storman and Donald Emmi to wrongfully prosecute and charge Jennifer Emmi, Donald Emmi's wife and mother of his three minor children with false charge and convict and imprison her wrongfully for 10 years in Denver Women's Correctional Facility. Jennifer was held for months cruelly in the Jefferson County jail in solitary confinement, cut off from even being able to speak to her mother on the phone and declined to roughly 80 pounds and was vomiting with blood present.

for 24 hours a day, 7 days a week Jennifer was kept in a solitary cell called Mou Cell #1 at the direction of Noelle Kerridge, Kate Knowles, and Alexis King. Donald Emmi dictated everything that happened as well during the entire year of prosecution and charges filed as well as the use of an ankle monitor on Jennifer Emmi and UA

testing.

Robert Hobar, David Wunderlich, and Donald Emmi were law partners and did a large merger deal, which yielded "substantial remuneration" according to Jacob Lilly who shared with Jennifer Emmi that this was the motivation for her imprisonment by Alexis King's office as she is married to David Wunderlich and concealed her conflict of interest in the high-profile case. Noelle Kerridge and Kate Knowles had separate conflict of interest that should have recused them early on as well.

These attorneys all must be investigated by ARC for many instances of highly unethical conduct and abuses of their law licenses and prosecutorial misconduct. Jennifer Emmi is seriously ill in prison and is innocent and risks dying in prison. She was forced to plead guilty and told her mother was charged with false felonies as well. The corruption and abuse of power ~~is~~ with these attorneys must be investigated thoroughly and immediately.

Colin Bresee and Malcolm Seawell - These attorneys, licensed in the State of Colorado represented Jennifer Emmi in 2020-2021 for several criminal cases. They convinced Jennifer Emmi to plead guilty and receive what Colin Bresee labeled "prophylactic probation" in return to pleading guilty. Jennifer was told the stalking charge was for charging her daughter's endoscopy to a later date Jennifer could be there to attend. The retaliation charge was for calling immigration. The murder to hire Colin said no one took seriously because no one believed anyone would hire Tim Lindsay for anything, "that's our position with this thing." Colin assured Jennifer's mother the same thing and Jennifer's mother rushed out to fill her home with foods, groomed Jennifer's dog, and made arrangements to see medical help since Jennifer was so ill in the jail.

The day of sentencing approached and Jennifer Emmi decided to withdraw the plea two separate times and Colin Bresee became very abusive. He was abusive many times during representation. He threatened his client Jennifer Emmi many times. Jennifer

had declined to little more than 80 pounds, vomited up blood and Colin and Malcolm did nothing to get her medically released.

Jennifer Emmi was not competent to even plead guilty and the guilty plea was invalid and only done under duress and forced. It was done under false pretenses. The charges were completely different than what Jennifer Emmi was lied to and told they were. She would have NEVER plead to what the charges really were and even tried several times (four) to withdraw the made up charges. She is innocent of all crimes.

Colin Bresee and Malcolm Seawell did not properly defend Jennifer Emmi or guide her or investigate her case. They even filed a poorly drafted 35(c) to withdraw her plea after she got to prison and failed to follow through on that again hurting her chances to withdraw her plea yet another time after promising her and apologizing to her. Please investigate both attorneys.
